**NOTICE OF COMMISSION'S FINDINGS OF FACT, CONCLUSIONS
OF LAW AND ORDER PURSUANT TO SECTION 111.07(5), STATS.**

On November 29, 2007, Examiner Raleigh Jones issued Findings of Fact, Conclusions of Law and Order, with Accompanying Memorandum in the above-entitled matter determining that the Respondent had committed a prohibited practice within the meaning of Sec. 111.70(3)(a)1, Stats. He ordered Respondent to take certain remedial action.¹

The Examiner further concluded that Respondent had not committed certain alleged prohibited practices within the meaning of Secs. 111.70(3)(a)2 and 3, (3)(b)1, 3, 4 and (3)c, Stats., and that he would not assert Commission jurisdiction an alleged violation of Sec. 111.70(3)(a)5, Stats.
