**NOTICE OF COMMISSION'S FINDINGS OF FACT, CONCLUSIONS OF LAW AND
ORDER PURSUANT TO SECTION 111.07(5), STATS.**

On October 10, 2011, Examiner Stuart D. Levitan issued Findings of Fact, Conclusions of Law and Order with Accompanying Memorandum in the above-entitled matter determining that Milwaukee County had committed a prohibited practice within the meaning of Sec. 111.70(3)(a)4, Stats. He ordered the County to take certain remedial action.
