NOTICE OF COMMISSION'S FINDINGS OF FACT, CONCLUSIONS OF LAW AND ORDER PURSUANT TO § 111.07(5), STATS.

On January 4, 2022, Examiner Peter G. Davis issued Findings of Fact, Conclusions of Law and Order with Accompanying Memorandum in the above-captioned matter determining that the Respondent Madison Metropolitan School District (MMSD) had committed prohibited practices within the meaning of Wis. Stat. § 111.70 (3)(a) 4 and derivatively Wis. Stat. § 111.70(3)(a) 1. The Examiner ordered Respondent to cease and desist from communicating as to base wages with MMSD employees represented for the purposes of collective bargaining by the Madison Teachers Incorporated (MTI) except if it wished to convey a base wage offer that has been previously provided to MTI, and ordered Respondent to take certain affirmative action. The Examiner further determined that the portion of the complaint alleging a violation of Wis. Stats. § 111.70 (3)(a) 2. and derivatively Wis. Stats. § 111.70 (3)(a) 1. is dismissed.

Within the 20-day statutory period set forth in Wis. Stat. § 111.07(5), no petition for review of said Findings of Fact, Conclusions of Law and Order was filed and no intervening order by the Examiner or the Commission was issued.
