- 1. That the Findings of Fact, Conclusions of Law and Order of the State Personnel Board dated June 26, 1962, which order sustained the action of the appointing authority as to the discharge of Austin L. Haffele from his position as an Aid I at Mendota State Hospital effective at 3:00 p.m. on December 26, 1961, be and they are hereby affirmed.
- 2.
