Steve Preller v. Wisconsin Personnel Commission et al.  
(L.C. #98-CV-2387)

Before Dykman, P.J., Vergeront and Roggensack, JJ.

The respondents move to dismiss this appeal as not timely filed. The appellant has not responded to the motion. Because the notice of appeal was not timely filed, we grant the motion and dismiss the appeal.

The final order was entered on December 6, 1999. Timely and accurate notice of entry of the order was served and filed within twenty-one days of entry of the order.

Therefore, under WIS. STAT. § 808.04(1) (1997-98),<sup>1</sup> the final day for filing a timely notice of appeal was January 20, 2000. Because Preller filed his notice of appeal on January 24, 2000, this court lacks jurisdiction over the appeal. WIS. STAT. RULE 809.10(1)(b).

IT IS ORDERED that the appeal is dismissed.
