MEMORANDUM ACCOMPANYING ORDER ON REHEARING

On rehearing, Trochinski continues to contend that the Respondents did not comply with Wisconsin Admin. Code ER-MRS 15.02 which states in pertinent part:

The director may authorize an involuntary transfer, upon written request by an appointing authority, due to performance, discipline or operational needs.

The evidence presented at the May 26, 2021 hearing satisfies the Commission that Department of Corrections (DOC) Secretary Carr instructed DOC staff to relay a written request to staff at the Department of Personnel Management (DPM) that Trochinski be involuntarily transferred. The evidence presented confirms that the written request was made and further persuades the Commission that the acting DPM Director then authorized the transfer. Thus, the evidence presented confirms compliance with ER-MRS 15.02 and establishes that the Commission did not err when it so concluded in its February 11, 2021 Decision and Order.
