DECISION AND ORDER DISMISSING APPEAL

On May 24, 2022, Sasha Straka filed an appeal with the Wisconsin Employment Relations Commission asserting she had been suspended for five days without just cause by the State of Wisconsin Department of Transportation (DOT). Pursuant to its obligations under Wis. Stat. § 230.445(3)(c)1., the Commission notified the parties that it appeared the appeal was untimely and invited any response to be filed on or before July 6. No response was filed.

Having considered the matter, the Commission concludes that Straka did not file her appeal within 14 days of her receipt of "the decision of the administrator" as required by Wis. Stat. § 230.445(3)(c)1.

The appeal is dismissed.

MEMORANDUM ACCOMPANYING DECISION AND ORDER DISMISSING APPEAL

Section 230.445 (3)(c) 1., Stats. provides in pertinent part:

An employee or an appointing authority may appeal a decision issued by the administrator under par. (b) by filing an appeal with the commission. The employee or appointing authority may not file an appeal with the commission under this paragraph later than 14 days after receiving the administrator's decision. [T]he commission shall determine whether all procedural requirements were completed properly and in a timely manner. If a procedural requirement was not met by the employee or if the appointing authority's appeal under this paragraph was not made in a timely manner, the commission shall dismiss the appeal.

Straka received "the administrator's decision" as to her suspension on May 9, 2022. Straka's appeal was received by the Commission at 5:33 pm on May 23, 2022. Because the Commission's office is closed as of 4:30 pm, the appeal was not filed until the next day-May 24, 2022. Therefore, Straka's appeal was one day late and must be dismissed as required by Wis. Stat. § 230.445(3)(c)1.
