## **LABOR RELATIONS MATTERS DECIDED BY THE WISCONSIN SUPREME COURT**

Unanimous Court concludes WERC correctly determined that the University of Wisconsin Hospital and Clinics Authority is not an “employer” under the Wisconsin Employment Peace Act. 2025 WI 29 (6/25) Case No. 2022CV003199.

In Green Bay Prof. Police Ass’n v City of Green Bay, 2021 AP 102 (4/23) Wisconsin Supreme Court determines the arbitrator’s award did not “manifestly disregard the law” articulated in Loudermill.

## **LABOR RELATIONS MATTERS DECIDED BY THE WERC**

**City of Racine**, Dec. No. 39447-B (WERC, 4/25 and Dec. No. 39446-B (WERC, 5/25)

WERC resolves health insurance related duty to bargain disputes under newly amended Sec. 111.70 (4)(mc) 6. Wis. Stats.

**State of Wisconsin**, Dec. No. 40693-A (WERC, 12/24)

WERC announces it will return to its pre-COVID practice of not counting mail ballots received after the date ballots are counted.

**State of Wisconsin**, Dec. No. 40699-A (Davis, 11/24) aff’d by operation of law

State of Wisconsin Department of Corrections found to have committed an unfair labor practice (interference with lawful concerted activity) by prohibiting union members from wearing jackets with a union insignia while working in a prison.

**City of Madison**, Dec. No. 40357-A (Davis, 5/24) aff’d by operation of law

Complaint filed by union steward dismissed for failing to prove that City actions impacting him had interfered with his protected rights or were based on hostility toward his exercise of protected rights.

**City of New Richmond**, Dec. No. 39954-A (Davis, 2/24) aff’d 39954-B (WERC, 5/24)

Where disciplinary charges are pending before the PFC, WERC will not exercise jurisdiction over a complaint alleging that the Employer is acting out of animus toward the employee's concerted activity.

**City of Milwaukee, Dec. No. 40246 (WERC, 4/24)**

WERC concludes that at least absent knowing employee consent, Section 111.70(3)(a) 6. of the Municipal Employment Relations Act does not allow for payment of dues monies to a union for any period of time prior to the date an employee authorizes the payment.

**MISCELLANEOUS LABOR RELATIONS MATTERS**

**Life after Abbottsford-????**

**Milwaukee County** Deputies grievance arbitration award (Davis 3/24)) resolves dispute over contractual right to retroactive back pay for former employees and discusses *Beaudette v. Eau Claire Cnty. Sheriff's Dep't*, 2003 WI App 153, 265 Wis. 2d 744, 668 N.W.2d 133 where the Court concluded that retroactive payments were part of a contractual agreement even where there was no specific reference to retroactivity for former employees.
